2009-2010 School Year

Towns of Carmel, Kent, Patterson, Putnam Valley and Southeast in Putnam County and East Fishkill in Dutchess County, New York.

School tax for the Towns of Patterson, Putnam Valley and Southeast in Putnam County, are to be paid directly to Sally Parfitt, Receiver of Taxes, Patterson Town Hall, 1142 Route 311, P.O. Box 421, Patterson, New York 12563, week days from 9:00 a.m. to 3:00 p.m., from September 1, through and including October 31, (Saturday, Sunday and Holidays excluded).

School tax for the Town of Kent are to be paid directly to Jean Johnson, Receiver of Taxes, Kent Town Hall, 25 Sybil's Crossing, Kent Lakes, NY 10512, week days from 9:00 a.m. to 2:00 p.m., September 1, through and including October 31, (Saturday, Sundays & Holidays excluded).

School tax for the Town of Carmel are to be paid directly to Kathleen Kraus, Receiver of Taxes, Carmel Town Hall, 60 McAlpin Avenue, Mahopac, NY 10541, week days from 8:30 a.m. to 4:30 p.m., September 1, through and including October 31, Saturdays during September only 9:00 a.m. to 12:00 p.m. (Sundays and Holidays excluded).

School tax (Putnam County) are due and payable, without penalty, from September 1, through September 30. Add 2% interest October 1, through October 31. Taxes may also be paid in installments if each total tax bill exceeds \$50.00. First half of the tax bill plus a 4% service charge is payable to collector from September 1, through September 15. The second half plus a 4% service charge is payable to the Putnam County Commissioner of Finance, 40 Gleneida Ave., Carmel, NY 10512, after November 1, but before March 15. Payments after March 15 must add 1% interest per month or part thereof, in addition to the 4% service charge.

School tax for the Town of East Fishkill are to be paid to Claudia D. Heckert, Receiver of Taxes Town Hall, 330 Route 376, Hopewell Junction, NY 12533, week days from 9:00 a.m. to 2:00 p.m., September 1, through and including October 31, (Saturday, Sunday & Holidays excluded).

School tax (Dutchess County) may be paid in installments if each total tax bill exceeds \$50.00. First half of the tax bill, plus a 5% service charge is payable to collector from September 1, through September 15. The second half plus a 5% service charge is payable to the Dutchess County Commissioner of Finance, 22 Market Street, Poughkeepsie, NY 12601.

After November 1, the list of unpaid taxes will be turned-over to the Putnam County Commissioner of Finance for collection and for re-levy on State, County and Town tax bills with penalty and interest added.

NOTE:

The interest-free tax payment period has been extended by five (5) business days to residents who are receiving the Enhanced STAR Exemption.
